We are looking for professional vendors to enhance our overall event. Applications must be accompanied by photos of your entire vending set up, and a list of products sold. We strive to avoid over-duplication of vendors to give our vendors (event partners) the best shot at successfully marketing their products at our event. When you become an event partner, you will have the opportunity for one-on-one interaction with Northwest Nitro Nationals (management) attendees. In addition to distributing your promotional material and product samples, you may generate leads via registration forms and door prize drawings. ### VENDOR SPACE INFO

- Display space \$600 flat fee.
- Vendors are permitted use of **professional looking** pop-up tents and banners. Please submit photos of your display set up with this application. Applications without photos will not be considered.
- Vendor row spaces are assigned by management.
- There is **NO** electrical on site. Vendors should provide their own generators for electricity needed. Generators should be quiet and not cause disturbance to attendees or other vendors.

### VENDOR APPROVAL PROCESS

- 1) Complete and submit attached application with required photos. Please submit your application at least 30 business days prior to event date.
- 2) The Northwest Nitro Nationals team will review your application and respond within 2 business days.
- 3) If your application is approved, payment and Certificate of Insurance (see below for requirements) will be required prior to the event.

### VENDOR APPLICATION REQUIREMENTS

- Certificate of Insurance with minimum \$2,000,000 liability limits listing Northwest Nitro Nationals, LLC and Dry Creek Recreation, LLC both as additional insured for duration of event dates.
- Event Vendor Information Sheet
- Hold Harmless Agreement (see below)

**VENDOR FEES**

- Vendor fees must be paid via PayPal link emailed to vendor upon acceptance of their application. Payment must be made within one week of acceptance. Spaces are sold on an acceptance and first come/first served basis, but will not be held past seven days after email notification of acceptance. Lack of payment in the aforementioned timeframe will result in forfeiture of space to another vendor.

**INSURANCE REQUIREMENTS**

- Liability insurance of at least \$2,000,000 (two million dollars)
